Subject: Reduced Length Guides

The OEMs can will supply reduced length guides if requested. However, MP and Kleemann supply reduced length guides at different lengths!

- Kleemann's reduced length guide = 2,500mm
- MP's reduced length guides = 3,750mm

Important – where you needed reduced guides for an MP product you must ensure your site can accommodate the dimensions MP can provide.

I also provide some background information clarifying the reasons why we offer reduced guides as a variation and not standard.

Background

- 1. In 2013 we delivered 244 lifts to site. Of these, not including Variation Orders (VOs) for reduced guides, we supplied 6 jobs with reduced guides FOC because we felt it was our fault! This equates to 97% of the jobs with no access problems(linked to this topic) (244 6 = 238/244 = 97%).
- 2. Of the 6 jobs we felt we should pay for the reduced guides etc these costs the Passenger lift business approximately £7,000. This does not include the 'cost' to our reputation due to customer's frustration; however, I can think of more critical areas of our process that cost our reputation more than this at the moment...
- 3. The £7k of costs is off set by those customers who read the quotes and requested via a VO reduced guides. The table below shows that we invoiced additional revenue in 2013 of £5,860.00. If we set off this against the costs in 2 above, we have a net loss of £1,140. Not great, but we could get smarter at pricing the VOs to cover FOC issues...

- 4. The OEMs have offered us reduced guides, but this will cost us circa €400 (divided €1.20 £333.00). This would mean a number of things:
- If we decided to go for reduced guides as standard and not pass on the cost to the customer this would cost Passenger lifts £83,250 (£333.00 per lift x 250 lifts)
- If we decided to go for reduced guides as standard and pass the cost onto the customer this would increase our selling price by £333.00 x 1.50% = £499.50 per lift increase in the selling price.
- At the moment, I do not think our business is in a position to accept either of the above.
- 5. We have looked at the Quotes from; Orona, Otis, Kone and Thyssen and all offer reduced guides as a Variation
- 6. We have improved the wording on our Quote so that under the Price of the lift we also remind the customer about the 'access question'.
- 7. On our BWD approval letter we include another reminder for the builder concerning 'access'
